MDEQ

Dana and Jeremy reported at the November 16, 2017 MALEHA meeting that a new memo will be sent out to LPH within the next couple of weeks rescinding the decision to discontinue the self-assessment option for the On-Site Program. There will be an option for LPH to drop self-assessment and have DEQ staff conduct the full program review.

EPA's 2016 Michigan Drinking Water Program Review indicated deficiencies in the following areas: Technology updates needed in our current data management/reporting system. NCWS program findings focused on meeting sampling frequency for each of our Type II supplies. Lastly, the report indicated a need for additional funding to MDEQ and LPH. The report did recognize program improvements initiated, however additional program enhancements are needed.
