Maternal Infant Health Program (MIHP)

- The Cycle 7 certification cycle begins April 1st, 2018. MIHP forms and the *Operations Guide* have been updated to coincide with the new cycle. A crosswalk outlining the differences between Cycle 6 and Cycle 7 is located on the MIHP website under the certification section of the *Current Providers* page.
- 2. Three new providers will begin the new five-day orientation cycle in April. All three will be practicing in southeast Michigan.
- 3. Several enhancements to the MIHP application in MILogin will go live in late March/early April. The enhancements aim to decrease data entry duplication and will assure that the discharge summaries will collect information consistent with the new Cycle 7. MIHP providers will be alerted to the specific changes once they are ready to deploy.
- 4. Thank you to the MIHP agencies, who participated in the Home Visitation Continuous Quality Improvement (CQI) survey! The current CQI project focuses on increasing home visitation staff knowledge and comfort with addressing tobacco cessation. The information provided will assist in developing new tools for home visitors to use with families who are working to decrease/cease tobacco use.

 - All funded regions are making progress on their respective infant mortalityrelated projects. The area(s) of each region's current focus is as follows:
 - Prosperity Region 1 Neonatal Abstinence Syndrome (NAS) and substance use in pregnant women
 - Prosperity Region 2&3 Increasing substance use screening in pregnant women at two pilot obstetrical clinic sites
 - Prosperity Region 4 Increasing substance use screening for pregnant women at two pilot provider offices and increasing enrollment and retention in evidence-based home visiting programs in 3 counties within the region
 - Prosperity Region 8 Increasing early entry into prenatal care
 - Prosperity Region 10 Increasing enrollment in evidence-based home visiting programs in two zip codes within the City of Detroit

Oral Health

Beginning July 1, 2018, Medicaid will be enhancing the adult dental benefit for **pregnant** women to carve this benefit into the Medicaid Health Plan (MHP) benefit package. This new policy will support increased access to dental care and facilitate the coordination of care that is known to be critical for improved maternal and infant health. Additional updates will be forthcoming.

The Oral Health Program has submitted a grant proposal to HRSA titled *Michigan Increasing Capacity of Oral Health in Rural Expansion* (MI CORE). Partners of the proposal include: Ferris State University and Central Michigan District Health Department (CMDHD). If funded, the partnership with CMDHD will result in a community oral health coordinator being hired to assist with promotion and education of oral health, integration of oral health into practices and care coordination. The grant funding period is 9/2018-8/2022. This is a competitive grant and awards will be announced late summer 2018.
